

**THE AGREEMENT ON COOPERATION**

**BETWEEN**

**Article 1**

The following bodies shall participate in implementation of the Agreement: from the side of and its outpost institution in Przasnysz coordinator Martyna Sternal-Rykowska and from the side of \_\_\_\_\_

**Article 2**

The cooperation shall concern:

1. Organize meetings with students of the School / University.
2. Allowing teachers or students of the School to participate in free conferences scientific, open lectures, seminars, lectures organized at college.
3. Enabling cooperation between students, students and members of student science clubs, consultations and mutual assistance of teachers in developing curriculum content and undertaking joint didactic projects.
4. Joint implementation of projects and research and development works.
5. Allowing students of the University to do internships.
6. Promoting the university/school.
7. Implementation of joint scientific research.
8. Publication of research papers and lectures in the form of manuscripts in journals of both Parties.
9. Exchange of publications and textbooks.

10. Organization of seminars for lecturers.

### **Article 3**

The Parties agreed to conduct exchange of the teaching and research staff via invitations made by the Rectors or authorized Deans of the Faculties or coordinators of the Agreement.

The following is regarded as the purpose of the exchange of teaching and research staff: participation in scientific conferences and seminars, as well as exchange of experience, coordination of cooperation plans and discussion on up-to-date scientific issues of interest to both Parties.

The detailed conditions of cooperation, especially the financing mechanisms and plan of exchange of the teaching and research staff shall be specified in separate Supplement to this Agreement for each particular case.

### **Article 4**

The present Agreement will be for indefinite period of time.

### **Article 5**

Any changes to the content of the Agreement as well as to the particular stages of joint activities can be implemented only in a written form under the mutual agreement of the both Parties hereof. Either Party has a right to cancel the Agreement via due notification of the other Party not less than three months prior to the suggested date of the Agreement cancellation.

### **Article 6**

The present Agreement is signed in two copies in Polish and two copies in English, all the texts are equally legally valid.

### **Article 7**

The Parties agree that in assessing the legal consequences arising from the present Agreement, as well as in the performance of all obligations will be guided by the laws of the country where the violation of the obligations occurs.

### **Article 8**

All disputes which might arise from interpretation and implementation of this Agreement shall be resolved by the School Director/Rectors or authorized Deans of the Faculties or coordinators of the Agreement or by the persons authorized by them on the basis of the powers of attorney granted in writing, under the mutual agreement.

### **Article 9**

This Agreement comes in force from the date of signing by both Parties.
